Receipt and Counting of EOI's

It was informed and recorded that a total of **Fifty-Two (52) prospective EOIs** were **received and counted** for the said EOI. All EOIs were received in **sealed envelopes** and were placed before the Committee at the time of bid opening.

Observation Regarding Multiple Envelopes

It was informed and recorded that two (02) sealed EOI envelopes were received from the same source, namely **M/s Jorhat Engineering Sales and Services**, and were duly acknowledged during the EOI opening process. As both sealed envelopes originated from the same courier source, the Committee initially decided to treat the same as **Part-A and Part-B** and accordingly numbered them under **Sl. No. 40** of the receipt register/list of EOIs.

The above decision was clearly informed to the representatives of the prospective bidders present on the online platform during the Video Conferencing (VC) session at the time of bid opening, and the same was noted and agreed to by the prospective bidders present.

Further, considering the large volume of EOI documents received, the Committee decided that the opening and detailed scrutiny/evaluation of the EOIs would be carried out at a subsequent stage of the EOI evaluation process by the duly constituted Evaluation Committee, strictly in accordance with the provisions of the EOI document and applicable rules and guidelines.

Upon further discussion and opening of the EOI documents on the next consecutive day, it was observed that the said two (02) sealed EOI envelopes, though received from the same courier source, pertained to **two distinct and separate entities**, namely:

1. **M/s Inditrend Manpower Consulting and Projects Private Limited**, and
2. **M/s Industrend Analytics Private Limited**.

It was further noted that an email dated **27 January 2026** was received from **M/s Inditrend Manpower Consulting and Projects Private Limited**, clarifying that due to an inadvertent error on the part of the courier



partner, the consignment was mistakenly addressed in the name of **M/s Jorhat Engineering Sales and Services** instead of **M/s Industrend Analytics Private Limited**. The firm also clarified that as both offices are located on the same Campus, the said unintentional mistake occurred during dispatch.

The matter was discussed and deliberated upon by the Committee in detail. After due consideration, the Committee concluded that although the courier source was the same, the two sealed EOI envelopes pertained to **two separate legal entities** and, therefore, shall be treated as **two independent EOIs**. Accordingly, the total number of EOI documents received stands at **Fifty-Two (52)**.


